(Regd.under Section-42 of the Companies Ordinance 1984 Now companies act 2017)"

- The quality of the paper must be **70 gram (imported)** for Sr. # 1, whereas for other items, **68 gram Pakistani paper** may be used
- The specimen of the printing material can be examined in the Head Office of PPHI-Balochistan and if any bidder wants to acquire sample shall have submitted Rs: 5,000/- as tender fee in form of DD or P.O in favor of PPHI-B

- All printing shall be done **in black and white** color. However, on top of all registers, the monogram of PPHI-Baluchistan and Govt of Baluchistan must be in required color.
- The binding of register must be in very good quality.
- The firm, after winning the contract, will be bound to submit the specimen of printing material for approval and subsequently, the work order shall be issued.
- The period for the completion of work is one month and in case of non-compliance, the tender shall be assumed as cancelled and the call deposit shall be forfeited.
- The original documents and original file must be presented at the time of physical verification and must have all allied documents related to different Government duties/taxes/custom duties etc.
- All bids Financial and Technical (in separate envelopes), must be accompanied by a Bid Security, amount to 2% of the total bid amount, in shape of Call Deposit in favor of People's Primary Healthcare Initiative the company's profiles, must be delivered to the Head Office of PPHI-B (Address: House No: 8-A Jinnah Town, Samungali Road, Quetta) At or before 22 march, 2022 during office hours.
- Copy of the Sale tax registration and NTN number are to be attached with the bid.
