- 2. The last date for submission of tenders, duly filled in, stamped & signed, is 29th September 2025 up to 09:00AM.
- 3. The tenders will be opened on the same day i.e. 29thSeptember, 2025, at 09:30AM in the office of DSM PPHI, Panjgur in the presence of the bidders who may wish to be present.
- 4. All bids must accompany Bid security @ 2% of the bid amount in the shape of pay order/Banker's cheque drawn in the name of PPHI-B DSU Panjgur with title "PPHI PANJGUR (PPHI-District Govt)"., without which the bid will be considered invalid and rejected without further processing.
- 5. Bids will be decided as per rules and procedures given in the BPPRA rules.
- 6. Bids must be submitted on the prescribed forms of PEC given in the Tender documents.
